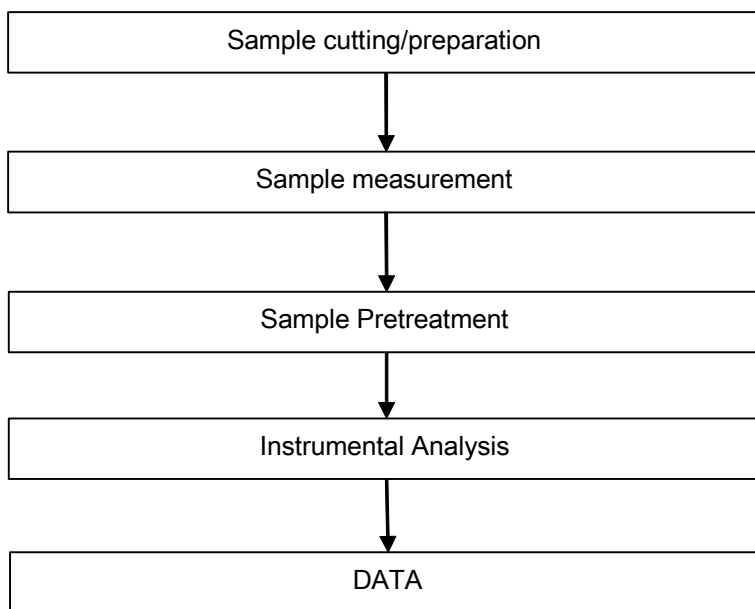

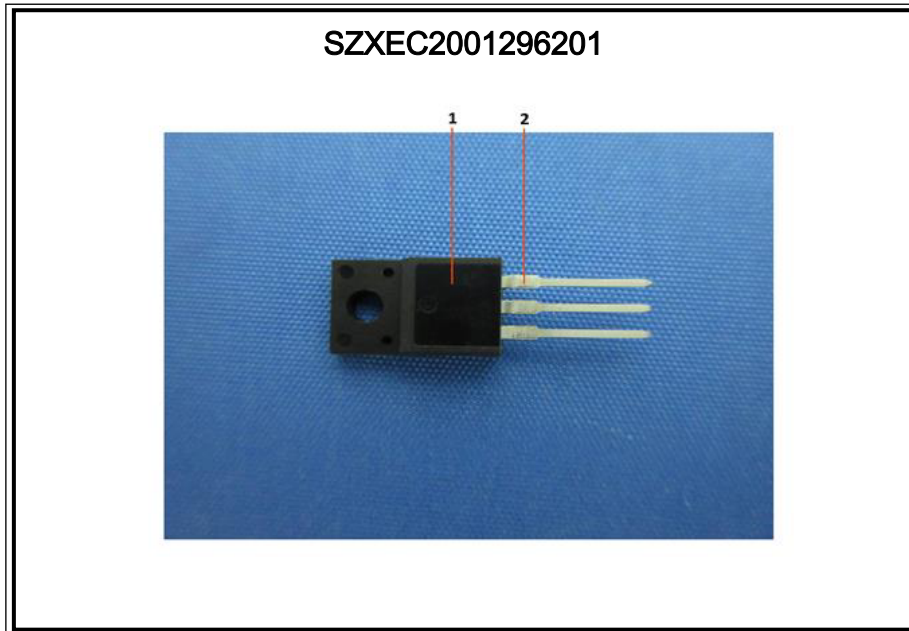
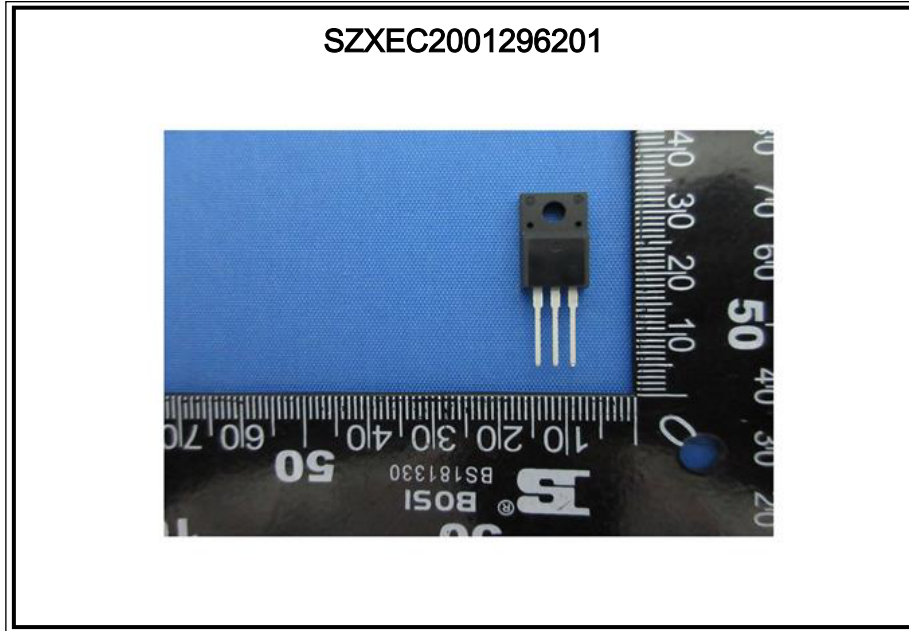
SVHC Testing Flow Chart
